

## **116th Congress Healthcare Reform Legislation Tracker**

### *Newly Included Legislation*

- July 16: Rep. Brad Wenstrup (R-OH) introduced the Family Savings Flexibility Act ([H.R. 7666](#)), which increases contribution limits for HSAs, among other things.
- July 30: Sen. Tina Smith (D-MN) introduced the Fair FSAs Act of 2020 ([S. 4371](#)), which requires plans to provide FSA reimbursements to individuals if they lose their employment or if their COBRA coverage expires, among other things.
- July 30: Sen. Tina Smith (D-MN) introduced the Dependent Care Expense Relief Act of 2020 ([S. 4372](#)), which specifies conditions for individuals to roll over certain FSA contributions, among other things.
- August 6: Sen. Cory Gardner (R-CO) introduced the Pre-Existing Conditions Protection Act of 2020 ([S. 4506](#)), which aims to ensure that coverage for pre-existing conditions will be maintained for health insurance market participants.
- August 14: Sen. Rand Paul (R-KY) and Rep. Andy Biggs (R-AZ) introduced the Health Savings Accounts for All Act ([S. 4367/H.R. 8032](#)), which eliminates the requirement that a participant in an HSA be enrolled in an HDHP, among other things.

<p style="text-align: center;"><b>Lower Health Care Costs Act of 2019</b> <a href="#">S. 1895</a> Sen. Lamar Alexander (R-TN)</p>	<p>Expands current broker compensation disclosures by requiring providers of brokerage or consulting services (“covered service providers” – broadly defined) to group health plans who reasonably expect \$1,000 or more in compensation, direct or indirect, in return for such services, to disclose to the plan fiduciary in writing:</p> <ul style="list-style-type: none"> <li>• A description of services to be provided;</li> <li>• If applicable, a statement that the service provider will provide, or reasonably expects to provide, services as a fiduciary;</li> <li>• A description of all direct (in aggregate or by service) and indirect compensation the provider reasonably expects to receive;</li> <li>• Descriptions of arrangements between covered service providers and payers of indirect compensation and identification of services for which the indirect compensation will be received;</li> <li>• A description of any transaction-based compensation that will be paid to the provider (e.g., commissions, finder’s fees, incentive comp, etc.), along with the payers and the services for which the compensation is being paid;</li> <li>• A description of any compensation the provider expects to receive for termination of the contract/arrangement and how prepaid amounts will be calculated and refunded;</li> <li>• A description of the manner in which any of the above-referenced compensation will be received; and</li> <li>• Upon the plan fiduciary’s request, any other information related to compensation.</li> </ul> <p>Incorporates various other provisions, including:</p> <ul style="list-style-type: none"> <li>• Requires disclosures be made no later than the date that “is reasonable in advance of” execution of a contract/arrangement, extension, or renewal;</li> <li>• Requires notification of changes to the information within 60 days;</li> <li>• Waives penalties for good faith errors if the provider promptly corrects any misinformation;</li> <li>• Requires that plan fiduciaries who discover that providers have not provided the above disclosures (if the error is left uncured) terminate the contract;</li> <li>• Does <b>not</b> preempt state laws governing broker/consultant disclosures.</li> </ul> <p><i>June 18 – A hearing was held on the legislation.</i></p> <p><i>June 26 – Approved by the Senate Committee on Health, Education, Labor and Pensions, as amended, by a vote of 20-3.</i></p>

<p><b>Jobs and Premium Protection Act</b> <a href="#">S. 80/H.R. 2447</a> Sen. John Barrasso (R-WY)/Rep. Anthony Brindisi (D-NY)</p>	<p>Repeals the ACA’s health insurance tax.</p>
<p><b>Health Insurance Tax Relief Act</b> <a href="#">S. 172/H.R. 1398</a> Sen. Cory Gardner (R-CO)/Rep. Ami Bera (D-CA)</p>	<p>Delays the implementation of the ACA’s health insurance tax until 2022.</p>
<p><b>Middle Class Health Benefits Tax Repeal Act of 2019</b> <a href="#">S. 684/H.R. 748</a> Sen. Martin Heinrich (D-NM)/Rep. Joe Courtney (D-CT)</p>	<p>Repeals the Cadillac tax. <i>July 17 – H.R. 748 was approved by the House by a vote of 419-6.</i></p>
<p><b>First Responder Medical Device Tax Relief Act</b> <a href="#">H.R. 1290</a> Rep. Michael Turner (R-OH)</p>	<p>Exempts certain emergency medical devices from the medical device tax.</p>
<p><b>Protect Medical Innovation Act of 2019</b> <a href="#">S. 692/H.R. 2207</a> Sen. Pat Toomey (R-PA)/Rep. Ron Kind (D-WI)</p>	<p>Repeals the medical device tax.</p>
<p><b>Territory Health Insurance Tax Relief Act of 2019</b> <a href="#">H.R. 2243</a> Rep. Jenniffer Gonzalez-Colon (R-PR)</p>	<p>Exempts residents of U.S. territories from the ACA’s health insurance tax.</p>
<p><b>Patient-Centered Outcomes Research Extension Act of 2019/PATIENT Act (similar though not identical)</b> <a href="#">H.R. 3030/H.R. 3439</a> Rep. Diana DeGette (D-CO)/Rep. Don Beyer (D-VA)</p>	<p>Extends appropriations and transfers to the Patient-Centered Outcomes Research Trust Fund and extends insured and self-insured health plan fees for such transfers from 2019 to 2029 (2026 for H.R. 3439 version). <i>June 26 – H.R. 3439, as amended, was approved by the Ways and Means Committee by a vote of 26-15.</i></p>
<p><a href="#">S. 2414</a> Sen. Rob Portman (R-OH)</p>	<p>Extends the Health Coverage Tax Credit from 2020 to 2025.</p>

<p><b>Dependent Income Exclusion Act of 2019</b> <a href="#">S. 2497/H.R. 4417</a> Sen. Catherine Cortez Masto (D-NV)/Rep. Steven Horsford (D-NV)</p>	<p>Excludes wages and self-employment earnings of a dependent when determining a taxpayer’s eligibility to receive tax credits for coverage under a qualified health plan if (1) the taxpayer resides in a Medicaid non-expansion state, or (2) the dependent of the individual is:</p> <ul style="list-style-type: none"> <li>• Under 18; or</li> <li>• Under 24 while (1) working full-time, (2) attending a for-profit educational institution, (3) participating in a job-training program, or (4) participating in an apprenticeship program.</li> </ul>

**Health Savings Accounts**

<p><b>Health Savings Act of 2019</b> <a href="#">S. 12</a> Sen. Marco Rubio (R-FL)</p>	<p><b>On-Site Clinics</b> – Creates a special rule for individuals eligible for on-site medical clinic coverage (eligibility to receive health care benefits from an on-site medical clinic of an employer does not qualify as coverage under a health plan if such health care benefits are not significant benefits). Examples of such benefits include:</p> <ul style="list-style-type: none"> <li>• Physicals and immunizations</li> <li>• Injecting antigens provided by employees</li> <li>• Medications available without a prescription (pain relievers, antihistamines, etc.)</li> <li>• Treatment for injuries occurring at the employer’s place of employment or otherwise in the course of employment</li> <li>• Tests for infectious diseases and conditions</li> <li>• Monitoring of chronic conditions</li> <li>• Drug testing</li> <li>• Hearing or vision screenings and related services</li> <li>• Other services and treatments of a similar nature</li> </ul> <p><b>OTC Medications</b> – Includes an amount paid for any prescription or OTC medicine or drug within the definition of a “qualified medical expense;” includes within the definition of “preventive care” prescription and OTC drugs.</p> <p><b>Contribution Amount</b> – Increases maximum contribution limit.</p> <p><b>Medicare Enrollment</b> – Allows Medicare beneficiaries enrolled only in Part A to continue to contribute to HSAs after turning 65 if otherwise eligible.</p> <p><b>Other</b> – Renames HDHP as “HSA-qualified health plan;” allows both spouses to make catch up contributions to the same HSA account; simplifies limitations on FSA and HSA rollovers; eliminates tax for failure to maintain HDHP coverage.</p>

<p><b>Health Savings Account Expansion Act</b> <a href="#">H.R. 603</a> Rep. Mike Gallagher (R-WI)</p>	<p><b>OTC Medications</b> – Repeals the restriction on using HSAs for OTC medications.</p> <p><b>Contribution Amount</b> – Increases maximum contribution limit.</p> <p><b>Other</b> – Permits the use of HSAs to pay health insurance premiums and direct primary care expenses; eliminates the requirement that a participant in an HSA be enrolled in an HDHP; decreases the additional tax for HSA distributions not used for qualified medical expenses.</p>
<p><b>Health Savings Account Act</b> <a href="#">H.R. 457</a> Rep. Jeff Fortenberry (R-NE)</p>	<p><b>Contribution Amount</b> – Increases maximum contribution limit.</p> <p><b>Other</b> – Allows HSAs to be used for fitness center memberships; allows individuals who receive direct primary care services in exchange for a fixed periodic fee or payment to participate in an HSA, among other things.</p>
<p><b>Personal Health Investment Today Act of 2019</b> <a href="#">S. 680</a> Sen. John Thune (R-SD)</p>	<p><b>Other</b> – Allows taxpayers to use HSAs or other pre-tax health accounts to pay for sports equipment and other fitness expenses.</p>
<p><b>Restoring Access to Medication Act</b> <a href="#">S. 1089/H.R. 1922</a> Sen. Pat Roberts (R-KS)/Rep. Ron Kind (D-WI) (similar)</p>	<p><b>OTC Medications</b> – Allows HSAs and FSAs to purchase OTC medications and menstrual care products (<i>Senate bill does not extend the protections to the purchase of menstrual care products</i>).</p> <p><i>October 23 – H.R. 1922 was approved by the House Ways and Means Committee, as amended, by voice vote.</i></p>
<p><b>Allowing Greater Access to Safe and Effective Contraception Act</b> <a href="#">S. 930</a> Sen. Joni Ernst (R-IA)</p>	<p><b>OTC Medications</b> – Repeals the tax on OTC medications for HSAs, Archer MSAs, and HRAs; and repeals the cap on contributions for FSAs, among other things.</p>
<p><b>Faith in Health Savings Accounts Act of 2019</b> <a href="#">H.R. 2177</a> Rep. Mike Kelly (R-PA)</p>	<p><b>Other</b> – Treats membership in a health care sharing ministry as coverage under a HDHP for purposes of contributing to an HSA.</p>
<p><b>Freedom for Families Act</b></p>	<p><b>Contribution Amount</b> – Increases maximum contribution limit.</p>

<p><a href="#">H.R. 2163</a> Rep. Andy Biggs (R-AZ)</p>	<p><b>Other</b> – Permits use of HSA funds during specific periods of “qualified caregiving” (e.g., the birth or adoption of a child/a family illness) in certain circumstances, among other things.</p>
<p><b>Homecare for Seniors Act</b> <a href="#">H.R. 2878</a> Rep. Katie Porter (D-CA)</p>	<p><b>Other</b> – Permits use of HSA funds for certain in-home services for senior citizens (e.g., assistance with daily tasks such as eating, bathing, dressing, etc.).</p>
<p><b>Chronic Disease Management Act of 2019</b> <a href="#">S. 1948</a> Sen. John Thune (R-SD)</p>	<p><b>Other</b> – Permits high deductible plans required for a HSA to provide chronic disease prevention and treatment with no deductible.</p>
<p><b>Healthcare Freedom Act of 2019</b> <a href="#">H.R. 3594</a> Rep. Chip Roy (R-TX)</p>	<p>Renames HSAs to Health Freedom Accounts (HFAs); allows all individuals to contribute to HFAs; permits the purchasing of health insurance coverage with HFAs; allows individuals to use HFAs for additional medical expenses (e.g., costs associated with direct primary care, health care sharing ministries, and medical cost sharing organizations); permits amounts paid or distributed from a HFA to rollover into another HFA.</p> <p><b>Contribution Amount</b> – Increases maximum contribution limit.</p> <p><b>Employer Contribution Exclusion</b> – Clarifies that gross income of an employee does not include amounts contributed by an employer to a HFA.</p>
<p><b>Veterans Health Savings Account Act</b> <a href="#">H.R. 3565</a> Rep. Paul Gosar (R-AZ)</p>	<p><b>Eligibility</b> – Requires that eligibility to contribute to HSAs not be affected by receipt of, or payment for, hospital care or medical services under any law administered by the Secretary of Veterans Affairs, including hospital care, medical services, and extended care services.</p>
<p><b>Primary Care Enhancement Act of 2019</b> <a href="#">S. 2999/H.R. 3708</a> Sen. Bill Cassidy (R-LA)/Rep. Earl Blumenauer (D-OR)</p>	<p><b>Eligibility</b> – Allows individuals with direct primary care service arrangements to remain eligible individuals for HSAs.</p> <p><i>October 23 – House version was approved by the House Ways and Means Committee, <a href="#">as amended</a>, by voice vote.</i></p>

<p><b>Health Savings for Seniors Act</b> <a href="#">H.R. 3796</a> Rep. Ami Bera (D-CA)</p>	<p><b>Eligibility</b> – Permits seniors enrolled in Medicare to continue using or create new HSAs; repeals the additional tax on distributions for Medicare beneficiaries; and repeals the Medicare limitation on deductions for contributions.</p>
<p><b>Keeping HSAs Accessible Act of 2019</b> <a href="#">H.R. 4130</a> Rep. Kenny Marchant (R-TX)</p>	<p><b>Eligibility</b> – Repeals the maximum deductible and out-of-pocket expense requirements for HSAs under high deductible health plans.</p>
<p><b>Health Savings Account Expansion Act of 2019</b> <a href="#">S. 2441</a> Sen. Ben Sasse (R-NE)</p>	<p><b>Eligibility</b> – Permits individuals enrolled in qualified health plans (e.g., including plans with coverage of benefits for no more than 80% of the full actuarial value of the benefits, and plans without deductibles for coverage such as preventive care, primary care, or prescription drug coverage)</p> <p><b>Contribution Amount</b> – Increases maximum contribution limit.</p>
<p><b>Qualified Health Savings Account Distribution Act of 2019</b> <a href="#">S. 2440</a> Sen. Ben Sasse (R-NE)</p>	<p><b>Other</b> – Specifies certain conditions for the distribution of funds from HRAs and FSAs to HSAs; expands the allowable amount of such distributions.</p>
<p><b>Health Savings for Families Act of 2019</b> <a href="#">H.R. 4576</a> Rep. Jennifer Wexton (D-VA)</p>	<p><b>Other</b> – Permits HSA contributions from individuals with spouses who have FSAs if the aggregate reimbursements under such FSAs do <b>not</b> exceed the aggregate expenses which would be eligible for reimbursement under the FSA for that spouse.</p>
<p><b>American Future Healthcare Act of 2019</b> <a href="#">H.R. 4651</a> Rep. Steve King (R-IA)</p>	<p><b>Eligibility</b> – Repeals the requirement for an individual to be covered by a HDHP for HSA contributions.</p> <p><b>Contribution Amount</b> – Increases the maximum contribution limit.</p> <p><b>Medicare Enrollment</b> – Permits Medicare eligible individuals to contribute to an HSA and permits rollover of HSA amounts to a Medicare Advantage Medical Savings Account (MSA).</p> <p><b>Other</b> – Allows individuals to use HSAs to purchase health insurance and allows certain primary care service fees to be treated as deductible medical expenses, among other things.</p>

<p><b>Primary Care Patient Protection Act</b> <a href="#">S. 2793</a> Sen. Angus King (I-ME)</p>	<p><i>Other</i> – Allows high deductible health plan holders to have two deductible-free primary care visits each year.</p>
<p><b>Personalized Care Act of 2019</b> <a href="#">S. 3112/H.R. 5596</a> Sen. Ted Cruz (R-TX)/Rep. Chip Roy (R-TX)</p>	<p><i>Eligibility</i> – Allows individuals covered by group or individual health plans; other health insurance coverage (including STLDI and medical indemnity plans); government programs (i.e., Medicare, Medicaid, CHIP, etc.); and healthcare sharing ministries to remain eligible for HSAs.</p> <p><i>Contribution Amount</i> – Increases maximum contribution limit.</p> <p><i>OTC Medications</i> – Allows HSAs to cover OTC medications.</p> <p><i>Other</i> – Permits the use of HSAs to pay health plan and insurance premiums, direct primary care expenses, certain medical care service arrangements, etc.; eliminates the requirement that a participant in an HSA be enrolled in an HDHP; and decreases the additional tax for HSA distributions not used for qualified medical expenses.</p>
<p><b>Patient Fairness Act of 2020</b> <a href="#">H.R. 5566</a> Rep. Warren Davidson (R-OH)</p>	<p><i>Eligibility</i> – Repeals the requirement for an individual to be covered by a HDHP for HSA contributions.</p> <p><i>Contribution Amount</i> – Increases maximum contribution limits.</p> <p><i>OTC Medications</i> – Allows HSAs to purchase OTC medications.</p> <p><i>Other</i> – Allows individuals to use HSAs to purchase health insurance; establishes an exception for relatives acquiring an HSA after the beneficiary is deceased; and codifies HHS’ hospital price transparency <a href="#">final rule</a>.</p>
<p><b>Veteran Access to Direct Primary Care Act</b> <a href="#">H.R. 6259</a> Rep. Chip Roy (R-TX)</p>	<p><i>Other</i> – Allows veterans to use HSAs for primary care services and any associated costs (e.g., physician fees, amounts paid/prepaid for certain medical services for wellness, and prescription or non-prescription drugs).</p>
<p><b>Health Savings Act of 2020</b> <a href="#">H.R. 6286</a> Rep. Michael Burgess (R-TX)</p>	<p><i>Eligibility</i> – Allows catastrophic and bronze plans to qualify for HSA contributions.</p> <p><i>Contribution Amount</i> – Increases maximum contribution limits.</p>



	<i>Other</i> – Permits a deduction for amounts paid to a designated child’s HSA and simplifies HSA rollovers to children, parents, and surviving spouses.
<b>Lower Health Insurance Deductibles Act</b> <a href="#">S. 3439</a> Sen. Rick Scott (R-FL)	<i>Other</i> – Allows high deductible health plan holders to divide annual deductibles between medical and drug costs in order to qualify for HSA contributions.
<b>H.R. 7242</b> Rep. John Curtis (R-UT)	<i>Other</i> – Eliminates the requirement that a participant in an HSA be enrolled in a HDHP; allows HSAs to be used for dietary nutritional supplements, telehealth services, premium payments for those enrolled in individual marketplace plans and who do not qualify for federal cost-sharing subsidies, and home gym equipment gym memberships; and allows dependents over age 16 to contribute to HSAs.
<b>Family Savings Flexibility Act</b> <a href="#">H.R. 7666</a> Rep. Brad Wenstrup (R-OH)	<i>Contribution Amount</i> – Increases maximum contribution limits. <i>Other</i> – Specifies certain conditions for the rollover of funds from FSAs.
<b>Fair FSAs Act of 2020</b> <a href="#">S. 4371</a> Sen. Tina Smith (D-MN)	<i>Other</i> – Requires plans to provide FSA reimbursements to individuals if they lose their employment or their COBRA coverage expires, among other things.
<b>Dependent Care Expense Relief Act of 2020</b> <a href="#">S. 4372</a> Sen. Tina Smith (D-MN)	<i>Other</i> – Specifies certain conditions for the rollover of funds from FSAs.
<b>Health Savings Accounts for All Act</b> <a href="#">S. 4367/H.R. 8032</a> Sen. Rand Paul (R-KY)/Rep. Andy Biggs (R-AZ)	<i>Other</i> – Eliminates the requirement that a participant in an HSA be enrolled in an HDHP; and eliminates tax for failure to maintain HDHP coverage, among other things.

<b>Family Health Care Affordability Act</b> <a href="#">H.R. 1870</a> Rep. Susan Wild (D-PA)	Amends the ACA’s affordability determinations to allow individuals with employer-sponsored health plans to receive ACA subsidies based on the affordability of family coverage, rather than self-only coverage, among other things.

<p><b>Health Care Affordability Act</b> <a href="#">H.R. 1868</a> Rep. Lauren Underwood (D-IL)</p>	<p>Expands eligibility for premium tax credits beyond 400% of the federal poverty line and increases the tax credit for all income brackets.</p>
<p><b>Employee Flexibility Act of 2019</b> <a href="#">S. 1510/H.R. 2782</a> Sen. Todd Young (R-IN)/Rep. Jackie Walorski (R-IN)</p>	<p>Amends the ACA’s definition of a “full-time employee” to 40 hours per week, as opposed to 30 hours.</p>
<p><b>Family Coverage Act</b> <a href="#">S. 1935</a> Sen. Sherrod Brown (D-OH)</p>	<p>Amends eligibility requirements for minimum essential health coverage under eligible employer-sponsored health plans by preventing such coverage if the required contribution to the plan exceeds 9.86% (as opposed to 9.5%) of the applicable taxpayer’s household income; defines the employee’s required contribution as the portion of the annual premium (without regard to whether paid through salary reduction or otherwise) for self and family coverage (i.e., the contribution amount for families is determined by self-only coverage).</p>
<p><b>Commonsense Reporting Act of 2019</b> <a href="#">S. 2366/H.R. 4070</a> Sen. Mark Warner (D-VA)/Rep. Mike Thompson (D-CA)</p>	<p>Amends sections 6055 and 6056 of the Internal Revenue Code to streamline current employer requirements by establishing a voluntary prospective reporting system to report general employee information in forms 1094-C and 1095-C.</p>
<p><b>Fair Indexing for Health Care Affordability Act</b> <a href="#">S. 2785/H.R. 5291</a> Sen. Jeanne Shaheen (D-NH)/Rep. Cynthia Axne (D-IA)</p>	<p>Shifts the indexing factor used to determine eligibility for the ACA’s premium tax credits back to premium growth from employer-sponsored plans (as opposed to premium growth across all private plans, as was finalized under the recent Trump Administration rule).</p>
<p><b>Advancing Youth Enrollment Act</b> <a href="#">S. 2735/H.R. 4927</a> Sen. Tammy Baldwin (D-WI)/Rep. Donald McEachin (D-VA)</p>	<p>Increases premium tax credits that are available to taxpayers with household members who are 18-34 years old.</p>
<p><b>American Healthshare Plans Act of 2020</b> <a href="#">S. 3610/H.R. 6712</a> Sen. Rand Paul (R-KY)/Rep. John Curtis (R-UT)</p>	<p>Amends the ERISA definition of employers to allow any membership organization to offer group insurance coverage or group health plans to its members (i.e., allowing smaller employers to enter the large group market) subject to employer-sponsored coverage requirements.</p>

<p><b>Competitive Health Insurance Reform Act of 2019</b> <a href="#">S. 350/H.R. 1418</a> Sen. Steve Daines (R-MT)/Rep. Peter DeFazio (D-OR)</p>	<p>Amends McCarran-Ferguson to clarify that it does not modify or supersede any antitrust laws with respect to health insurance.</p>

<p><b>No Health Care, No Raise Act</b> <a href="#">H.R. 3271</a> Rep. Josh Harder (D-CA)</p>	<p>Annually prohibits pay raises for Members of Congress unless HHS certifies that all U.S. citizens for the previous year were enrolled in health insurance coverage that minimally provided ACA essential health benefits.</p>

<p><b>Continuing Coverage for Preexisting Conditions Act</b> <a href="#">S. 3383/H.R. 383</a> Sen. John Kennedy (R-LA)/Rep. David Joyce (R-OH)</p>	<p>Ensures that the ACA’s prohibition against preexisting condition exclusions is protected if the ACA is found to be unconstitutional or otherwise invalid.</p>
<p><b>Preexisting Conditions Protection Act</b> <a href="#">H.R. 692</a> Rep.
